

Residential Rebate Application Form (Revised 07/27/11)

- ◆ Please note: Participants in this public program must provide proof of their lawful presence in the United States according to provisions of Colorado Law (Immigration Law, HB 06S-1023).
- ◆ The toilet rebate is valid for the replacement of **pre-1994 toilets**. Entire toilet must be replaced.
- ◆ Washer rebates are limited to 1 washing machine per household.
- ◆ Pre-owned and leased appliances do not qualify for the rebate.
- ◆ New fixture(s) may be selected for inspection by a City of Thornton representative.
- ◆ The rebate will be credited to the customer's water bill.

IMPORTANT TOILET REBATE STEPS:

Step 1 - EPA WaterSense toilets must be on the approved list to qualify for the \$125 rebate. Refer to <http://www.epa.gov/watersense/pp/het.htm> for a list of approved EPA WaterSense toilets.



Step 2 - Replace water-wasting pre-1994 toilet with new toilet. Home must have a built date of 1994 or earlier to qualify for the toilet rebate. No exceptions.

Step 3 - Keep the store receipt.

Step 4 - Break the old toilet and take a picture of the old, broken toilet. A picture of each broken toilet must be attached to this rebate form. This is required to ensure the old toilet is permanently out of service.

IMPORTANT WASHING MACHINE REBATE STEPS:

Step 1 - Before you purchase, download and print out the latest Consortium for Energy Efficiency (CEE) list from <http://www.cee1.org/resid/seha/rwsh/ResWashQualifyingProductList.xls> or <http://www.cee1.org/resid/seha/rwsh/rwsh-prod.pdf> and bring it with you when shopping for a new washing machine. The Manufacturer and Model Number of the new washing machine must be on this list to qualify for a rebate. Keep the store receipt.



Step 2 - Replace old washer with a new qualifying washer.

Step 3 - Take a picture of the new, installed washing machine and attach it to the rebate form.

FINAL STEPS FOR TOILET AND WASHING MACHINE REBATES:

Step 4 - Fill out the provided form and attach copy of itemized receipt(s) and photograph(s).

Step 5 - Sign the affidavit of US residency and **mail or bring legal proof of US residency (Usually a driver's license - name on the identification must match the name on the utility account) with the rebate form to:**
