## WATER-WISE LANDSCAPE REBATE

### 2025 Rules, Requirements & Application

This rebate program provides **up to \$1 per square foot** for low-water grass seed/sod areas and **up to \$2 per square foot** for perennial gardens and other projects, based upon total project costs. The lifetime rebate limit is 1,000 sq ft per account holder.

#### Before You Start Digging In, Be Sure You Qualify

1. Review Rules & Requirements and complete the checklist on the application form to verify that your landscape is eligible.
2. Complete the [Water-Wise Landscape Rebate application](#) and send to [Water@ThorntonWater.com](mailto:Water@ThorntonWater.com).
3. Take “before” photos of your proposed area before you start work, taken from multiple angles.

#### Digging Into Your Landscape Transformation

1. Follow the steps in your free H2Overhaul Kit. Download your kit at [thorntonwater.com/h2overhaul/get-your-kit](https://thorntonwater.com/h2overhaul/get-your-kit).
2. Visit [waterwiseyards.org](https://waterwiseyards.org) for inspiration, success stories and design ideas.
3. Create and submit your design (including plant and material list) to Thornton Water for approval.
4. Submit your design to your HOA for review and approval, if applicable.
5. Locate utilities at [www.colorado811.org](https://www.colorado811.org).
6. Wait to receive design approval from Thornton Water and your HOA.
7. Keep ALL your receipts.
8. Email photos of installed plants BEFORE adding mulch to plant beds to [Water@ThorntonWater.com](mailto:Water@ThorntonWater.com) and include your address.
9. Schedule a site visit when your project is complete - [Water@ThorntonWater.com](mailto:Water@ThorntonWater.com) or call 720-977-6600.

#### Qualifying Landscape Design Plan

Refer to Sample Design located at the end of this document to help create a qualifying plan. Plans must be to scale and include:

1. Customer name, address, date, and north arrow.
2. Measurements and proposed square footage of project area.
3. Legend including identification and quantities of plant types and materials.
4. Outline of area proposed for renovation with existing elements identified.
5. Location of new landscape elements, materials, and plants.
6. Irrigation system design, if applicable.
7. An outline of phasing plans, if applicable.
8. Plant bed design must show estimated plant size at maturity (3-5 years) to show that the no more than 30 percent bare mulch requirement will be met. Example for a 1000 square foot project:  
 $(30 \times 100) \div 1000 = 300$  square feet of bare mulch/rock is allowed.
9. HOA approval, if applicable.

Participants may include the following in their overall design, but these items will NOT be included in the project costs or rebate-eligible square footage: Vegetable plants, annual plants, raised beds, impermeable concrete, water feature/fountains, horseshoe pits, bocce ball, sand volleyball court and bare rock beds.

Soil amendments are required for areas where new plants or grass will be installed. Edging or wall blocks are required to separate lawn or perennial gardens from other areas.

#### Qualifying Irrigation Plan

Automatic irrigation systems are not required. Manual watering is allowed but must be noted as the watering method in the Irrigation Plan. Plans must be to scale and include:

1. Customer name, address, date and north arrow.
2. Legend, including irrigation controller, backflow device, existing sprinkler equipment and layout. (Audit report that includes a map of existing zones is acceptable from Resource Central's Slow the <https://resourcecentral.org/sprinklers/residential/>), proposed sprinkler equipment and layout.
3. Drip emitters must match plant needs.
4. Drip zones must have pressure regulator.
5. Drip zone may not be combined with other types of sprinklers; (drip cannot be on the same zone as spray or rotor heads).

#### Qualifying Mulched Plant Beds

1. No more than 30 percent bare mulch (at plant mature size.) Example for a 1000 square foot project:  $(30 \times 100) \div 1000 = 300$  square feet of bare mulch/rock is allowed.
2. Eligible mulch types include shredded bark, bark chips or rock.
3. A majority of plants must be ultra-low to low water requirement perennials, shrubs or trees.
4. Limit 2 large or 4 small trees per 1,000 sq. ft.
5. A maximum of 30 percent moderate water demand plants will be accepted.
6. Eligible plant lists (other water-wise plants will be considered on a case-by-case basis). Vegetable gardens do not qualify. Seed mixes and bulbs do not qualify.

#### Qualifying Low to No Water Turf Zones

Qualifying grass seed or sod areas will receive a rebate of up to **\$1/sq. ft.** Soil amendment is required. Low-water turf information: <https://www.thorntonwater.com/h2overhaul/plants-alt-turf/>.

1. Cool Season Turf- documented water savings of 30 percent or more compared to Kentucky Bluegrass
  - 💧 Turf Type Tall Fescue
  - 💧 Fine Fescues (only Sheep, Blue and Hard fine fescues)
  - 💧 Texas Hybrid Bluegrass Sod
2. Warm Season Turf- documented water savings of 50 percent or more compared to Kentucky Bluegrass
  - 💧 Mix of Buffalograss and Blue Grama
  - 💧 Dog Tuff™ Grass from Plantselect.org
  - 💧 Tahoma 31 Sod (Bermudagrass)

#### Artificial Turf

Artificial turf is eligible in front, side and back yards and must be professionally installed and PFAS-free to receive a **\$2/sq. ft.** rebate. Specific rules for artificial turf - [Artificial Turf Rebate Information and Rules](#).

#### Qualifying Permeable Hardscapes

Installation of hardscapes such as flagstone or paver paths, up to 4 feet wide, and patios qualify. Hardscape entertainment spaces must be permeable to qualify. Note: Concrete patios and rock-mulched areas without plants are not considered permeable hardscapes and are not eligible.

#### Qualifying Decks

Decks must replace an area of irrigated landscape to qualify.

#### Qualifying Rebate Payment

The rebate amount cannot be greater than the total project cost. Rebates greater than \$600 are subject to income tax. Thornton will send a 1099 tax form to all rebate participants who receive a rebate payment. Consult a tax professional for more information.

*By participating in the landscape rebate program, you consent to the City using photographs or videos of your project, which may be used for promotional purposes on the City's website, other public platforms and other outreach methods, without further notification or compensation, unless you explicitly opt-out by contacting the Water Resources Division.*

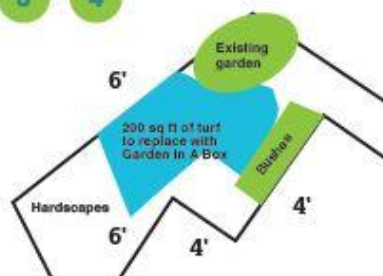

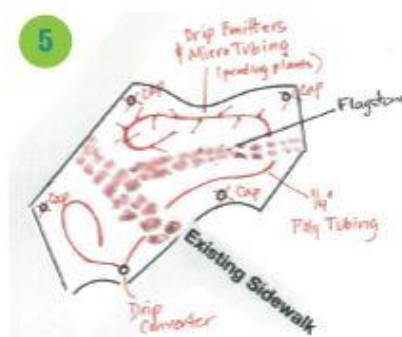

Approved water-wise landscape projects will receive up to **\$2 per square foot** rebate for artificial turf or perennial garden or up to **\$1 per square foot** for pre-approved water-wise grass seed/sod, up to two months after Thornton Water's approval of the completed project. The rebate will apply to a 200 to 1,000 square foot area. **Completed project deadline is October 31st.**
