Thornton residents have made great strides in becoming more water-efficient over the past two decades, reducing average residential water use by **39**%.

From replacing old toilets and irrigation controllers to sprinkler evaluations and water-wise yard transformations, residents are taking action to save.

Achieve annual water savings of 2,322 acre feet or more than 756 million gallons, enough water to serve all Thornton Water customers for over a month each year!

- Commercial/HOA water-wise landscape grant.
- · Commercial indoor water use assessments.
- Commercial/HOA irrigation system rebate.
- Custom commercial indoor water efficiency rebate.
- Residential, commercial, and HOA landscape design.

- Youth Water Festival.
- Demonstration garden tours and maintenance.
- · Conservation kit distribution.
- Water-wise landscape workshops.

Summer water demand peaks at an average of 44 million gallons per day (MGD), so reducing irrigation demand lowers the seasonal strain on Thornton's two water treatment plants and underground water pipes.
